**Have a Voice on the Future of CTE:** As a membership organization, Advance CTE directly relies on our members to inform our [legislative priorities](#) for federal laws such as the Carl D. Perkins Career and Technical Education Act (Perkins), Every Student Succeeds Act (ESSA) and Workforce Innovation & Opportunity Act (WIOA) and Higher Education Act (HEA). These laws make up the core of Advance CTE's successful advocacy efforts with Congress and the Administration. We speak for our members and need your voice.

In addition, our members drive our research and inform a multitude of case studies, reports, fact sheets and tools that are most needed on the topics of greatest importance to you. More broadly, our members' participation in events such as our in-person meetings and webinars as well as their input into surveys guarantees we have a strong foundation of knowledge and guidance to accomplish the mission, vision and goals of the organization.

**Gain Access to Unique Resources and Professional Development:** Advance CTE members have access to the growing [Members Only section](#) of our website.
