Advance CTE:FY21



- Financials reconciled through 2/28/21 or 67% of fiscal year
- Received 100% of budgeted income
- Expended 42% of budgeted expenses
- Organization is strong and healthy

The Center to Advance CTE: FY21



- Financials reconciled through 2/28/21 or 67% of fiscal year
- Received 97.5% of budgeted income
- Expended 51.6% of budgeted expenses
- Organization is strong and healthy

Update on Advance CTE Accomplishments and from the Board of Directors

Member Satisfaction



- **100%** of State Directors reporting they are "very satisfied" or "satisfied" with value of membership
- **96%** of State Associate Members reporting they are "very satisfied" or "satisfied" with value of membership
- **85%** of Non-State Associate & Organizational Members reporting they are "very satisfied" or "satisfied" with value of membership

Impact & Influence

- **67%** of states report using at least one Advance CTE resource to influence policy and/or practice
- **54%** of states report working to replicate state examples from at least one Advance CTE resource
- **100%** of State Directors and **69%** of others have shared Advance CTE resources with their staff, colleagues and/or other networks
- **84%** of State Directors and **76%** of others reported that Advance CTE resources are often or usually relevant to the issues they face in their state

Equity



I view Advance CTE as a leading expert on equity in CTE:

- 3.26 out of 4 (State Directors)
- 3.43 out of 4 (non-State Directors)
- 3.31 out of 4 (non-State Directors who identified race/ethnicity other than White)
