


## **Goals of the Alignment Study**

#### **Policy Scan Pilot**

- Diverse selection of 10 pilot states
  - o Geographic
  - Secondary vs. Postsecondary Governance
  - State vs. Locally Developed Standards
- State/Territory CTE policy analysis

#### **Alignment Study Pilot**

- Gather standards from 10 pilot states
- Map state standards against knowledge & skills domains in CCTC



#### **Full Scale Study**

- Conduct policy scan and alignment study for remaining 45 States /Territories
- Dissemination of final state reports

## **Policy Scan Pilot**

- ⇔ Goal: Determine what states need to know and do to institute a systemic shift toward implementation of CCTC and the most efficient way to collect this information
- ⇔ *Timing:* January 28 March 29
- ⇔ *Participants:* Diverse selection of 10 pilot states
- ⇔ *Collection Method:* Requests to 10 pilot CTE State Directors:

(GSX to contact via email/phone early February)

- Are there state adopted and implemented standards for CTE?
- Can you provide policy structure/legislation that supports implementation of standards in your state/territory?
- ⇔ Analysis: GSX to analyze adoption, implementation, and maintenance infrastructure

⇔ **Reporting:** GSX & OSU CETE to create reporting template



#### **Alignment Study Pilot**

- ⇔ Goal: Determine the extent to which state/territory standards align with the CCTC and the most efficient way to conduct this analysis
- ⇔ *Timing:* January 31 March 29
- ⇔ *Participants:* Diverse selection of 10 pilot states (from Policy Scan Pilot)
- ⇔ *Collection Method:* Requests to 10 pilot CTE State Directors:

(GSX to request via email early February):

- Specific and up-to-date CTE standards
- ⇔ *Analysis:* GSX to categorize and enter data, align data to CCTC
- ⇔ **Reporting:** GSX & OSU CETE to create reporting template
- ⇔ Corrections: "Lessons learned" during the pilot will inform full-scale study April-August



## Full Scale Study

- ⇔ Goal: To conduct a full scale policy scan and alignment study of the remaining states/territories
- ⇔ *Timing*: April August (2 Phases)
- ⇔ *Participants:* Remaining states/territories
- ⇔ Collection Method: Requests to remaining 45 State/Territory Directors:

(GSX to contact via email in April for Phase 1; June for Phase 2)

- Specific and up-to-date CTE standards
- Policy information supporting implementation of standards
- ⇔ Analysis: GSX to:
  - Analyze adoption, implementation, and maintenance infrastructure and categorize
  - Enter standards data; align to CCTC



### **Final Reporting & Database**

#### Study Reports

- Each state/territory to receive customized report including policy scan and alignment study results upon completion
- Summary report highlighting results across all states/territories

#### ⇔ Database

- Access database will be created over the course of the study to provide membership with the ability to search/query both policy and standards information across all states/territories
- Database user guide for search/queries
- NASDCTEc to provide access to stored information

#### ⇔ Final Release of Report and Database at Fall Conference in October 2013
