#### **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Educating Tomorrow's
- 5 Workforce Act of 2014.".

### 1 SEC. 2. DEFINITIONS.

6	Section 134(b) of the Carl D. Perkins Career and
7	Technical Education Act of 2006 (20 U.S.C. 2354(b)) is

9	(1) in paragraph (3)(A), by striking "programs
10	of study described in section 122(c)(1)(A)" and in-
11	serting "education programs of study"; and
