## Sequestration

- Sequestration provisions from Budget Control Act of 2011 went into effect on March 1, 2013.
- Total cuts to ED = \$2.478 billion
- Perkins reduced by 5.2%



- From \$1.123 to \$1.065 billion = Total loss of \$59 million starting July 1, 2013
- Resulted in different cuts for different states due to two provisions:
  - Minimal Allocation Rule
  - Hold Harmless



# Reality Works Survey: Impact of Sequestration on CTE

- Survey of 9 states: CA, CO, FL, IL, MI, NJ, NY, NC, PA
  - These states combined receive about 38% of Perkins Grant funds
- Sequestration's Negative Impact on CTE
  - Funding reductions resulting in restrictions related to hiring staff, travel, equipment, purchasing curricula, etc.
  - Impacting state and local levels through program offerings, staffing levels, and reduced support services to teachers and students



# **Continuing Resolution**

 Funding for FY13 will end on September 30, 2013 = Possible Federal government shutdown




- Continuing Resolution
  - Allows federal agencies and programs to continue to temporarily operate at current funding levels into next fiscal year.
- House-approved Continuing Resolution seeks to deny funding for Affordable Care Act.



### **Debt Ceiling Debates**

- Debt ceiling no later than October 17th
- U.S. technically hit debt ceiling in May but Treasury Department has been taking "extraordinary measures" to avoid default







## Legislation: Carl D. Perkins CTE Act

- Perkins reauthorization process has begun
- House Education and Workforce Subcommittee on Early Childhood, Elementary and Secondary Education
- Hearing: "Preparing Today's Students for Tomorrow's Jobs: A Discussion on Career and Technical Education and Training Programs"

# Legislation: Elementary and Secondary Education Act

- May: Negotiations between members of the HELP committee broke down over disagreements on establishing performance targets for school accountability (R- oppose; D- support)
- Harkin introduced partisan Democratic bill S. 1094 Strengthening America's Schools Act (Bill out of committee, pending Senate-wide vote)
- June: House Education & Workforce Committee passed its ESEA Reauthorization bill – The Student Success Act (H.R. 5)



### Legislation: Workforce Investment Act

- In March, House Education & Workforce Committee passed the H.R. 803 Supporting Knowledge and Investing in Lifelong Skills (SKILLS) Act
- In June, Senate HELP Committee began WIA reauthorization process with hearings. Committee passed this draft, (S.1356)
  - Pending a full vote in the Senate with suggested amendments



## **Legislation: Higher Education Act**

- Authorization expires at end of 2013
- Congress began hearings and started collecting input in May 2013
- President Obama has made college affordability an Administrative priority





### **Related to HEA**

- August: Legislation reduces federal loan interest rates temporarily from 6.8% to 3.86% for undergraduates and 5.4% for graduate students
- Dept. of Ed Gainful Employment rule-making panel
  - 15 Members
  - Unanimous consensus needed
  - 1<sup>st</sup> round finished, 2<sup>nd</sup> starts next month



# **Other CTE Legislation**

- Student Right to Know Before You Go Act
  - Senators Wyden (D-OH), Rubio
    (R-FL), Warner (D-VA); Representatives
    Hunter (R-CA) and Andrews (D-NJ)



- Career Through Responsive, Efficient and Effective Retraining Act (CAREER Act)
  - Senators Portman (R-OH) and Bennet (D-OH)
- Building Understanding, Investment, Learning and Direction in CTE Act (BUILD CTE Act)
  - Senator Merkley (D-OR)
