29 **SEC. 2. [20 U.S.C. 2301] PURPOSE.**

30 The purpose of this Act is to develop more fully the academic knowledge and technical and
31 employability~~career and technical~~ skills of secondary education students and postsecondary
32 education students who elect to enroll in career and technical education programs and programs
33 of study, by—

1 (1) building on the efforts of States and localities to develop challenging academic and
2 technical standards and to assist students in meeting such standards, including preparation
3 for high skill, high wage, or ~~high-in-~~demand occupations in current or emerging
4 professions;

5 (2) promoting the development of services and activities that integrate rigorous and
6 challenging academic and career and technical instruction, and that link secondary
7 education and postsecondary education for participating career and technical education
8 students;

9 (3) increasing State and local flexibility in providing services and activities designed to
10 develop, implement, and improve career and technical education, ~~including tech prep~~
11 ~~education~~;

12 (4) conducting and disseminating national research and disseminating information on best
13 practices that improve career and technical education programs and programs of study,
14 services, and activities;

15 (5) providing technical assistance that—

16 (A) promotes leadership, initial preparation, and professional development at the
17 State and local levels; and

18 (B) improves the quality of career and technical education teachers, faculty,
19 administrators, and counselors;

20 (6) supporting partnerships among secondary schools, postsecondary institutions,
21 baccalaureate degree granting institutions, area career and technical education schools,
22 local workforce investment boards, business and industry, and intermediaries; ~~and~~

23 (7) providing individuals with opportunities throughout their lifetimes to develop, in
24 conjunction with other education and training programs, the knowledge and skills needed
25 to keep the United States competitive; ~~and~~

26 (8) increasing the employment opportunities for populations who are chronically
27 unemployed or underemployed, including individuals with disabilities, individuals from
28 economically disadvantaged families, out-of-workforce individuals, youth who are in, or
29 have aged out of, the foster care system, and homeless individuals.

31 SEC. 3. [20 U.S.C. 2302] DEFINITIONS.

32 Unless otherwise specified, in this Act:

33 (1) Administration.—The term “administration”, when used with respect to an eligible
34 agency or eligible recipient, means activities necessary for the proper and efficient
35 performance of the eligible agency or eligible recipient’s duties under this Act, including
36 the supervision of such activities. Such term does not include curriculum development
37 activities, personnel development, or research activities.

38 (2) All aspects of an industry.—The term “all aspects of an industry” means strong
39 experience in, and comprehensive understanding of, the industry that the individual is
40 preparing to enter, ~~including information as described in section 118.~~

1 (3) Area career and technical education school.—The term “area career and technical
2 education school” means—

3 (A) a specialized public secondary school used exclusively or principally for the
4 provision of career and technical education to individuals who are available for study
5 in preparation for entering the labor market;

6 (B) the department of a public secondary school exclusively or principally used for
7 providing career and technical education in not fewer than 3 different fields that are
8 available to all students, especially in high-skill, high-wage, or in-demand industry
9 sectors or occupations ~~5 different occupational fields to individuals who are available~~
10 ~~for study in preparation for entering the labor market;~~

11 (C) a public or nonprofit technical institution or career and technical education school
12 used exclusively or principally for the provision of career and technical education to
13 individuals who have completed or left secondary school and who are available for
14 study in preparation for entering the labor market, if the institution or school admits,
15 as regular students, individuals who have completed secondary school and individuals
16 who have left secondary school; or

17 (D) the department or division of an institution of higher education, that operates
18 under the policies of the eligible agency and that provides career and technical
19 education in not fewer than 35 different occupational fields leading to immediate
20 employment but not necessarily leading to a baccalaureate degree, if the department
21 or division admits, as regular students, both individuals who have completed
22 secondary school and individuals who have left secondary school.

23 (4) Articulation agreement.—The term “articulation agreement” means a written
24 commitment—

25 (A) that is agreed upon at the State level or approved annually by the lead
26 administrators of—

27 (i) a secondary institution and a postsecondary educational institution; or

28 (ii) a subbaccalaureate degree granting postsecondary educational institution and
29 a baccalaureate degree granting postsecondary educational institution; and

30 (B) to a program that is—

31 (i) designed to provide students with a nonduplicative sequence of progressive
32 achievement leading to technical skill proficiency, a credential, a certificate, or a
33 degree; and

34 (ii) linked through credit transfer agreements between the 2 institutions described
35 in clause (i) or (ii) of subparagraph (A) (as the case may be).

36 (5) Career and technical education.—The term “career and technical education” means
37 organized educational activities that—

38 (A) offer a sequence of courses that—

39 (i) provides individuals with rigorous academic content and relevant technical
40 knowledge and skills needed to prepare for further education and careers in

1 current or emerging professions, which may include high-skill, high-wage, or in-
2 demand industry sectors or occupations, which shall be, at the secondary level,
3 aligned with the challenging State academic standards adopted by a State under
4 section 1111(b)(1) of the Elementary and Secondary Education Act of
5 1965; provides individuals with coherent and rigorous content aligned with
6 challenging academic standards and relevant technical knowledge and skills
7 needed to prepare for further education and careers in current or emerging
8 professions;

9 (ii) provides technical skill proficiency or a recognized postsecondary credential,
10 which may include an industry-recognized credential, a certificate, or an associate
11 degree, an industry-recognized credential, a certificate, or an associate degree;
12 and

13 (iii) may include prerequisite courses (other than a remedial course) that meet the
14 requirements of this subparagraph; ~~and~~

15 (B) include competency-based, work-based, or other applied learning that ~~contributes~~
16 ~~to supports the development of the~~ academic knowledge, higher-order reasoning and
17 problem-solving skills, work attitudes, ~~general~~ employability skills, technical skills,
18 and occupation-specific skills, and knowledge of all aspects of an industry, including
19 entrepreneurship, of an individual-;

20 (C) to the extent practicable, coordinate between secondary and postsecondary
21 education programs through programs of study, which may include coordination
22 through articulation agreements, early college high school programs, dual or
23 concurrent enrollment program opportunities, or other credit transfer agreements that
24 provide postsecondary credit or advanced standing; and

25 (D) may include career exploration at the high school level or as early as the middle
26 grades (as such term is defined in section 8101 of the Elementary and Secondary
27 Education Act of 1965).

28 (6) Career and technical student organization.—

29 (A) In general.—The term “career and technical student organization” means an
30 organization for individuals enrolled in a career and technical education program that
31 engages in career and technical education activities as an integral part of the
32 instructional program.

33 (B) State and national units.—An organization described in subparagraph (A) may
34 have State and national units that aggregate the work and purposes of instruction in
35 career and technical education at the local level.

36 (7) Career guidance and academic counseling.—The term “career guidance and academic
37 counseling” means guidance and counseling that—

38 (A) provides access for students (and, as appropriate, parents and out-of-school youth;
39 as appropriate) to information regarding career awareness exploration opportunities
40 and planning with respect to an individual’s occupational and academic future; ~~and~~

41 (B) provides information to students (and, as appropriate, parents and out-of-school
42 youth) with respect to career options, financial aid, job training, secondary and

1 postsecondary options (including associate and baccalaureate degree programs), dual
2 or concurrent enrollment programs, work-based learning opportunities, early college
3 high schools, financial literacy, and support services, as appropriate; and

4 (C) may provide assistance for special populations with respect to direct support
5 services that enable students to persist in and complete career and technical
6 education, programs of study, or career pathways.

7 (8) Career pathways.—The term ‘career pathways’ has the meaning given the term in
8 section 3 of the Workforce Innovation and Opportunity Act (29 U.S.C. 3102).

9 (98) Charter school.—The term “charter school” has the meaning given the term in
10 section 4310 of the Elementary and Secondary Education Act of 1965.

11 (109) Cooperative education.—The term “cooperative education” means a method of
12 education for individuals who, through written cooperative arrangements between a
13 school and employers, receive instruction, including required rigorous and challenging
14 academic courses and related career and technical education instruction, by alternation of
15 study in school with a job in any occupational field, which alternation—

16 (A) shall be planned and supervised by the school and employer so that each
17 contributes to the education and employability of the individual; and

18 (B) may include an arrangement in which work periods and school attendance may be
19 on alternate half days, full days, weeks, or other periods of time in fulfilling the
20 cooperative program.

21 ~~(10) Displaced homemaker.—The term “displaced homemaker” means an individual~~
22 ~~who—~~

23 ~~(A)(i) has worked primarily without remuneration to care for a home and family, and~~
24 ~~for that reason has diminished marketable skills;~~

25 ~~(ii) has been dependent on the income of another family member but is no longer~~
26 ~~supported by that income; or~~

27 ~~(iii) is a parent whose youngest dependent child will become ineligible to receive~~
28 ~~assistance under part A of title IV of the Social Security Act (42 U.S.C. 601 et~~
29 ~~seq.) not later than 2 years after the date on which the parent applies for assistance~~
30 ~~under such title; and~~

31 ~~(B) is unemployed or underemployed and is experiencing difficulty in obtaining or~~
32 ~~upgrading employment.~~

33 (11) Credit transfer agreement.—The term ‘credit transfer agreement’ means a formal
34 agreement, such as an articulation agreement, among and between secondary and
35 postsecondary education institutions or systems that grant students transcribed
36 postsecondary credit, which may include credit granted to students in dual or concurrent
37 enrollment programs, early college high school, dual credit, articulated credit, and credit
38 granted on the basis of performance on technical or academic assessments.

39 (12) CTE concentrator.—The term ‘CTE concentrator’ means—

40 (A) at the secondary school level, a student served by an eligible recipient who has

1 completed at least 2 courses in a single career and technical education program or
2 program of study; and

3 (B) at the postsecondary level, a student enrolled in an eligible recipient who has—

4 (i) earned at least 12 credits within a career and technical education program or
5 program of study; or

6 (ii) completed such a program if the program encompasses fewer than 12 credits
7 or the equivalent in total.

8 (13) CTE participant.—The term ‘CTE participant’ means an individual who completes
9 not less than one course in a career and technical education program or program of study
10 of an eligible recipient.

11 (14) Director.—The term ‘Director’ means the Director of the Institute of Education
12 Sciences.

13 (15) Dual and concurrent enrollment program.—The term ‘dual or concurrent enrollment
14 program’ has the meaning given the term in section 8101 of the Elementary and
15 Secondary Education Act of 1965.

16 (16) Early college high school.—The term ‘early college high school’ has the meaning
17 given the term in section 8101 of the Elementary and Secondary Education Act of 1965.

18 (1744) Educational service agency.—The term “educational service agency” has the
19 meaning given the term in section 8101 of the Elementary and Secondary Education Act
20 of 1965.

21 (1842) Eligible agency.—The term “eligible agency” means a State board designated or
22 created consistent with State law as the sole State agency responsible for the
23 administration of career and technical education in the State or for the supervision of the
24 administration of career and technical education in the State.

25 (19) Eligible entity.—The term ‘eligible entity’ means a consortium that includes the
26 following:

27 (A) Representatives of not less than 2 of the following categories of entities, 1 of
28 which shall serve as the fiscal agent for the consortium:

29 (i) A local educational agency or a consortium of such agencies.

30 (ii) An educational service agency serving secondary school students.

31 (iii) An area career and technical education school or a consortium of such
32 schools.

33 (iv) An Indian Tribe, Tribal organization, or Tribal education agency.

34 (v) An institution of higher education whose most common degree awarded is an
35 associate degree, or a consortium of such institutions.

36 (vi) An institution of higher education whose most common degree awarded is a
37 bachelor's or higher degree, or a consortium of such institutions.

38 (vii) A state educational agency.

1 (B) One or more business or industry representative partners, which may include
2 representatives of local or regional businesses or industries, including industry or
3 sector partnerships in the local area, local workforce development boards, or labor
4 organizations.

5 (C) One or more stakeholders, which may include —

6 (i) parents and students;

7 (ii) representatives of local agencies serving out-of-school youth, homeless
8 children and youth, and at-risk youth (as defined in section 1432 of the
9 Elementary and Secondary Education Act of 1965 (20 U.S.C. 6472));

10 (iii) representatives of Indian tribes and Tribal organizations, where applicable;

11 (iv) representatives of minority serving institutions (as described in paragraphs (1)
12 through (7) of section 371(a) of the Higher Education Act of 1965 (20 U.S.C.
13 1067q(a)), where applicable;

14 (v) representatives of special populations;

15 (vi) representative of adult career and technical education providers; or

16 (vii) other relevant community stakeholders.

17 (2013) Eligible institution.—The term “eligible institution” means—

18 (A) a consortium of 2 or more of the entities described in subparagraphs (B) through
19 (F);

20 (B) a public or nonprofit private institution of higher education that offers and will
21 use funds provided under this title in support of career and technical education
22 courses that lead to technical skill proficiency or a recognized postsecondary
23 credential, including an industry-recognized credential, a certificate, or an associate
24 degree;

25 (C) a local educational agency providing education at the postsecondary level;

26 (D) an area career and technical education school providing education at the
27 postsecondary level;

28 (E) an Indian Tribe, Tribal organization, or Tribal education agency that operates a
29 school or may be present in the State;

30 (F) a postsecondary educational institution controlled by the Bureau of Indian
31 Education or operated by or on behalf of any Indian Tribe that is eligible to contract
32 with the Secretary of the Interior for the administration of programs under the Indian
33 Self-Determination and Education Assistance Act (25 U.S.C. 5301 et seq.) or the Act
34 of April 16, 1934 (25 U.S.C. 5342 et seq.);

35 (G) a tribally controlled college or university; or

36 (H) an educational service agency.

37 ~~(A) a public or nonprofit private institution of higher education that offers career and~~
38 ~~technical education courses that lead to technical skill proficiency, an industry-~~
39 ~~recognized credential, a certificate, or a degree;~~

1 ~~(B) a local educational agency providing education at the postsecondary level;~~

2 ~~(C) an area career and technical education school providing education at the~~
3 ~~postsecondary level;~~

4 ~~(D) a postsecondary educational institution controlled by the Bureau of Indian Affairs~~
5 ~~or operated by or on behalf of any Indian tribe that is eligible to contract with the~~

12 (2144) Eligible recipient.—The term “eligible recipient” means—

13 (A) a local educational agency (including a public charter school that operates as a
14 local educational agency), an area career and technical education school, an
15 educational service agency, an Indian Tribe, Tribal organization, or Tribal educational
16 agency or a consortium, eligible to receive assistance under section 131; or

17 (B) an eligible institution or consortium of eligible institutions eligible to receive
18 assistance under section 132.

19 (22) English learner.—The term ‘English learner’ means—

20 (A) a secondary school student who is an English learner, as defined in section 8101
21 of the Elementary and Secondary Education Act of 1965; or

22 (B) an adult or an out-of-school youth who has limited ability in speaking, reading,
23 writing, or understanding the English language and—

24 (i) whose native language is a language other than English; or

25 (ii) who lives in a family environment or community in which a language other
26 than English is the dominant language.

27 (23) Evidence-based.—The term ‘evidence-based’ has the meaning given the term in
28 section 8101(21)(A) of the Elementary and Secondary Education Act of 1965.

29 (2445) Governor.—The term “Governor” means the chief executive officer of a State.

30 (25) High school.—The term ‘high school’ has the meaning given the term in section
31 8101 of the Elementary and Secondary Education Act of 1965.

32 (26) In-demand industry sector or occupation.—The term ‘in-demand industry sector or
33 occupation’ has the meaning given the term in section 3 of the Workforce Innovation and
34 Opportunity Act (29 U.S.C. 3102).

35 ~~(16) Individual with limited english proficiency.~~—The term “individual with limited
36 ~~English proficiency” means a secondary school student, an adult, or an out-of-school~~
37 ~~youth, who has limited ability in speaking, reading, writing, or understanding the English~~
38 ~~language, and—~~

39 ~~(A) whose native language is a language other than English; or~~

1 (B) who lives in a family or community environment in which a language other than
2 English is the dominant language.

3 (27) Indian; Indian Tribe.— The terms ‘Indian’ and ‘Indian Tribe’ have the meanings
4 given the terms ‘Indian’ and ‘Indian tribe’, respectively, in section 4 of the Indian Self-
5 Determination and Education Assistance Act (25 U.S.C. 5304).

6 (2847) Individual with a disability.—

7 (A) In general.—The term “individual with a disability” means an individual with any
8 disability (as defined in section 3 of the Americans with Disabilities Act of 1990 (42
9 U.S.C. 12102)).

10 (B) Individuals with disabilities.—The term “individuals with disabilities” means
11 more than 1 individual with a disability.

12 (29) Industry or sector partnership.—The term ‘industry or sector partnership’ has the
13 meaning given the term in section 3 of the Workforce Innovation and Opportunity Act
14 (29 U.S.C. 3102).

15 (3048) Institution of higher education.—The term “institution of higher education” has
16 the meaning given the term in section 101 of the Higher Education Act of 1965.

17 (3149) Local educational agency.—The term “local educational agency” has the meaning
18 given the term in section 8101 of the Elementary and Secondary Education Act of 1965.

19 (32) Local workforce development board.—The term ‘local workforce development
20 board’ means a local workforce development board established under section 107 of the
21 Workforce Innovation and Opportunity Act (29 U.S.C. 3122).

22 (3320) Non-traditional fields.—The term “non-traditional fields” means occupations or
23 fields of work, ~~such as including~~ careers in computer science, technology, and other
24 current and emerging high skill occupations, for which individuals from one gender
25 comprise less than 25 percent of the individuals employed in each such occupation or
26 field of work.

27 (3424) Outlying area.—The term “outlying area” means the United States Virgin Islands,
28 Guam, American Samoa, the Commonwealth of the Northern Mariana Islands, and the
29 Republic of Palau.

30 (35) Out-of-school youth.—The term ‘out-of-school youth’ has the meaning given the
31 term in section 3 of the Workforce Innovation and Opportunity Act (29 U.S.C. 3102).

32 (36) Out-of-workforce individual.—The term ‘out-of-workforce individual’ means—

33 (A) an individual who is a displaced homemaker, as defined in section 3 of the
34 Workforce Innovation and Opportunity Act (29 U.S.C. 3102); or

35 (B) an individual who—

36 (i) (I) has worked primarily without remuneration to care for a home and family,
37 and for that reason has diminished marketable skills; or

38 (II) is a parent whose youngest dependent child will become ineligible to
39 receive assistance under part A of title IV of the Social Security Act (42
40 U.S.C. 601 et seq.) not later than 2 years after the date on which the parent

1 applies for assistance under such title; and

2 (ii) is unemployed or underemployed and is experiencing difficulty in obtaining
3 or upgrading employment.

4 (37) Paraprofessional.—The term ‘paraprofessional’ has the meaning given the term in
5 section 8101 of the Elementary and Secondary Education Act of 1965.

6 (38) Pay for success initiative:

7 (A) In General.—Subject to subparagraph (B), the term ‘pay for success initiative’
8 means a performance-based grant, contract, or cooperative agreement awarded by a
9 State or local public entity (such as a local educational agency) to a public or private
10 non-profit entity—

11 (i) in which a commitment is made to pay for improved outcomes that result in
12 increased public value and social benefit to students and the public sector, such as
13 improved student outcomes as evidenced by the indicators of performance
14 described in section 113(b)(2) and direct cost savings or cost avoidance to the
15 public sector; and

16 (ii) that includes—

17 (I) a feasibility study on the initiative describing how the proposed
18 intervention is based on evidence of effectiveness;

19 (II) a rigorous, third-party evaluation that uses experimental or quasi-
20 experimental design or other research methodologies that allow for the
21 strongest possible causal inferences to determine whether the initiative has
22 met its proposed outcomes;

23 (III) an annual, publicly available report on the progress of the initiative; and

24 (IV) a requirement that payments are made to the recipient of a grant,
25 contract, or cooperative agreement only when agreed upon outcomes are
26 achieved, except that the entity may make payments to the third party
27 conducting the evaluation described in subparagraph (II).

28 (B) Exclusion. —The term ‘pay for success initiative’ does not include any initiative
29 that—

30 (i) reduces the special education or related services that a student would otherwise
31 receive under the Individuals with Disabilities Education Act; or

32 (ii) otherwise reduces the rights of a student or the obligations of an entity under
33 the Individuals with Disabilities Education Act, the Rehabilitation Act of 1973
34 (29 U.S.C. 701 et seq.), the Americans with Disabilities Act of 1990 (42 U.S.C.
35 12101 et seq.), or any other law.

36 (3922) Postsecondary educational institution.—The term “postsecondary educational
37 institution” means—

38 (A) an institution of higher education that provides not less than a 2-year program of
39 instruction that is acceptable for credit toward a bachelor’s degree;

40 (B) a tribally controlled college or university; or

1 (C) a nonprofit educational institution offering certificate or other skilled training
2 apprenticeship programs at the postsecondary level.

3 (40) Professional development.—The term ‘professional development’ means activities
4 that—

5 (A) are an integral part of eligible agency, eligible recipient, institution, or school
6 strategies for providing educators (including teachers, principals, other school leaders,
7 administrators, specialized instructional support personnel, career guidance and
8 academic counselors, and paraprofessionals) with the knowledge and skills necessary
9 to enable students to succeed in career and technical education, to meet challenging
10 State academic standards under section 1111(b)(1) of the Elementary and Secondary
11 Education Act, or to achieve academic skills at the postsecondary levels; and

12 (B) are sustained (not stand-alone, 1-day, or short-term workshops), intensive,
13 collaborative, job-embedded, data-driven, and classroom-focused, to the extent

1 annually to Congress on the Secretary's aggregate analysis of performance information
2 collected each year pursuant to this title from eligible agencies under section
3 113(b)(3)(C), including an analysis of performance data regarding special populations.

4 (2) Compatibility.—The Secretary shall, to the extent feasible, ensure that the
5 performance information system is compatible with other Federal information systems.

6 (3) Assessments.—As a regular part of its assessments, the National Center for Education

8 nationally representative sample of students. Such assessment may include international
9 comparisons in the aggregate.

13 SEC. 131. [20 U.S.C. 2351] DISTRIBUTION OF FUNDS TO 14 SECONDARY EDUCATION PROGRAMS.

15 (a) Distribution Rules.—Except as provided in section 133 and as otherwise provided in this
16 section, each eligible agency shall distribute the portion of funds made available under
17 section 112(a)(1) to carry out this section to local educational agencies within the State as
18 follows:

19 (1) Thirty percent.—Thirty percent shall be allocated to such local educational agencies
20 in proportion to the number of individuals aged 5 through 17, inclusive, who reside in the
21 school district served by such local educational agency for the preceding fiscal year
22 compared to the total number of such individuals who reside in the school districts served
23 by all local educational agencies in the State for such preceding fiscal year, as determined
24 on the basis of the most recent satisfactory—

25 (A) data provided to the Secretary by the Bureau of the Census for the purpose of
26 determining eligibility under title I of the Elementary and Secondary Education Act
27 of 1965; or

28 (B) student membership data collected by the National Center for Education Statistics
29 through the Common Core of Data survey system.

30 (2) Seventy percent.—Seventy percent shall be allocated to such local educational
31 agencies in proportion to the number of individuals aged 5 through 17, inclusive, who
32 reside in the school district served by such local educational agency and are from families
33 below the poverty level for the preceding fiscal year, as determined on the basis of the
34 most recent satisfactory data used under section 1124(c)(1)(A) of the Elementary and
35 Secondary Education Act of 1965, compared to the total number of such individuals who
36 reside in the school districts served by all the local educational agencies in the State for
37 such preceding fiscal year.

38 (3) Adjustments.—Each eligible agency, in making the allocations under paragraphs (1)
39 and (2), shall adjust the data used to make the allocations to—

1 (A) reflect any change in school district boundaries that may have occurred since the
2 data were collected; and

3 (B) include local educational agencies without geographical boundaries, such as
4 charter schools and secondary schools funded by the Bureau of Indian
5 Affairs Education.

6 (b) Waiver for More Equitable Distribution.—The Secretary may waive the application of
7 subsection (a) in the case of any eligible agency that submits to the Secretary an application
8 for such a waiver that—

9 (1) demonstrates that a proposed alternative formula more effectively targets funds on the
10 basis of poverty (as defined by the Office of Management and Budget and revised
11 annually in accordance with section 673(2) of the Community Services Block Grant Act
12 (42 U.S.C. 9902(2))) to local educational agencies within the State than the formula
13 described in subsection (a); and

14 (2) includes a proposal for such an alternative formula.

15 (c) Minimum Allocation.—

16 (1) In general.—Except as provided in paragraph (2), a local educational agency shall not
17 receive an allocation under subsection (a) unless the amount allocated to such agency
18 under subsection (a) is greater than \$15,000. A local educational agency may enter into a
19 consortium with other local educational agencies for purposes of meeting the minimum
20 allocation requirement of this paragraph.

21 (2) Waiver.—The eligible agency shall waive the application of paragraph (1) in any case
22 in which the local educational agency—

23 (A) (i) is located in a rural, sparsely populated area; or

24 (ii) is a public charter school operating secondary school career and technical
25 education programs or programs of study; and

26 (B) demonstrates that the local educational agency is unable to enter into a
27 consortium for purposes of providing activities under this part.

28 (3) Redistribution.—Any amounts that are not allocated by reason of paragraph (1) or
29 paragraph (2) shall be redistributed to local educational agencies that meet the
30 requirements of paragraph (1) or (2) in accordance with the provisions of this section.

31 (d) Limited Jurisdiction Agencies.—

32 (1) In general.—In applying the provisions of subsection (a), no eligible agency receiving
33 assistance under this title shall allocate funds to a local educational agency that serves
34 only elementary schools, but shall distribute such funds to the local educational agency or
35 regional educational agency that provides secondary school services to secondary school
36 students in the same attendance area.

37 (2) Special rule.—The amount to be allocated under paragraph (1) to a local educational
38 agency that has jurisdiction only over secondary schools shall be determined based on the
39 number of students that entered such secondary schools in the previous year from the
40 elementary schools involved.

1 (e) Allocations to Area Career and Technical Education Schools and Educational Service
2 Agencies.—

3 (1) In general.—Each eligible agency shall distribute the portion of funds made available
4 under section 112(a)(1) for any fiscal year by such eligible agency for career and
5 technical education activities at the secondary level under this section to the appropriate
6 area career and technical education school or educational service agency in any case in
7 which the area career and technical education school or educational service agency, and
8 the local educational agency concerned—

9 (A) have formed or will form a consortium for the purpose of receiving funds under
10 this section; or

11 (B) have entered into or will enter into a cooperative arrangement for such purpose.

12 (2) Allocation basis.—If an area career and technical education school or educational
13 service agency meets the requirements of paragraph (1), then the amount that would
14 otherwise be distributed to the local educational agency shall be allocated to the area
15 career and technical education school, the educational service agency, and the local
16 educational agency based on each school, agency or entity's relative share of students
17 who are attending career and technical education programs (based, if practicable, on the
18 average enrollment for the preceding 3 years).

19 (3) Appeals procedure.—The eligible agency shall establish an appeals procedure for
20 resolution of any dispute arising between a local educational agency and an area career
21 and technical education school or an educational service agency with respect to the
22 allocation procedures described in this section, including the decision of a local
23 educational agency to leave a consortium or terminate a cooperative arrangement.

24 (f) Consortium Requirements.—

25 (1) Alliance.—Any local educational agency receiving an allocation that is not sufficient
26 to conduct a program which meets the requirements of section 135 is encouraged to—

27 (A) form a consortium or enter into a cooperative agreement with an area career and
28 technical education school or educational service agency offering programs that meet
29 the requirements of section 135;

30 (B) transfer such allocation to the area career and technical education school or
31 educational service agency; and

32 (C) operate programs that are of sufficient size, scope, and quality to be effective.

33 (2) Funds to consortium.—Funds allocated to a consortium formed to meet the
34 requirements of this subsection shall be used only for purposes and programs that are
35 mutually beneficial to all members of the consortium and can be used only for programs
36 authorized under this title. Such funds may not be reallocated to individual members of
37 the consortium for purposes or programs benefitting only 1 member of the consortium.

38 (g) Data.—The Secretary shall collect information from eligible agencies regarding the
39 specific dollar allocations made available by the eligible agency for career and technical
40 education programs and programs of study under subsections (a), (b), (c), (d), and (e) and
41 how these allocations are distributed to local educational agencies, area career and technical

1 education schools, and educational service agencies, within the State in accordance with this
2 section.

3 (h) Special Rule.—Each eligible agency distributing funds under this section shall treat a
4 secondary school funded by the Bureau of Indian ~~Affairs~~ Education within the State as if
5 such school were a local educational agency within the State for the purpose of receiving a
6 distribution under this section.

8 SEC. 132. [20 U.S.C. 2352] DISTRIBUTION OF FUNDS FOR 9 POSTSECONDARY EDUCATION PROGRAMS.

10 (a) Allocation.—

11 (1) In general.—Except as provided in subsections (b) and (c) and section 133, each
12 eligible agency shall distribute the portion of the funds made available under section
13 112(a)(1) to carry out this section for any fiscal year to eligible institutions or consortia of
14 eligible institutions within the State.

15 (2) Formula.—Each eligible institution or consortium of eligible institutions shall be
16 allocated an amount that bears the same relationship to the portion of funds made
17 available under section 112(a)(1) to carry out this section for any fiscal year as the sum of
18 the number of individuals who are Federal Pell Grant recipients and recipients of
19 assistance from the Bureau of Indian Affairs enrolled in programs meeting the
20 requirements of section 135 offered by such institution or consortium in the preceding
21 fiscal year bears to the sum of the number of such recipients enrolled in such programs
22 within the State for such year.

23 (3) Consortium requirements.—

24 (A) In general.—In order for a consortium of eligible institutions described in
25 paragraph (2) to receive assistance pursuant to such paragraph, such consortium shall
26 operate joint projects that—

27 (i) provide services to all postsecondary institutions participating in the
28 consortium; and

29 (ii) are of sufficient size, scope, and quality to be effective.

30 (B) Funds to consortium.—Funds allocated to a consortium formed to meet the
31 requirements of this section shall be used only for purposes and programs that are
32 mutually beneficial to all members of the consortium and shall be used only for
33 programs authorized under this title. Such funds may not be reallocated to individual
34 members of the consortium for purposes or programs benefitting only 1 member of
35 the consortium.

36 (4) Waiver.—The eligible agency may waive the application of paragraph (3)(A)(i) in
37 any case in which the eligible institution is located in a rural, sparsely populated area.

38 (b) Waiver for More Equitable Distribution.—The Secretary may waive the application of
39 subsection (a) if an eligible agency submits to the Secretary an application for such a waiver
40 that—

1 (1) demonstrates that the formula described in subsection (a) does not result in a

10 shall be redistributed to eligible institutions or consortia in accordance with this section.

12 **SEC. 133. [20 U.S.C. 2353] SPECIAL RULES FOR CAREER**
13 **AND TECHNICAL EDUCATION.**

14 (a) Special Rule for Minimal Allocation.—

15 (1) General authority.—Notwithstanding the provisions of sections 131 and 132 and in
16 order to make a more equitable distribution of funds for programs serving the areas of
17 greatest economic need, for any program year for which a minimal amount is made
18 available by an eligible agency for distribution under section 131 or 132, such eligible
19 agency may distribute such minimal amount for such year—

20 (A) on a competitive basis; or

21 (B) through any alternative method determined by the eligible agency.

22 (2) Minimal amount.—For purposes of this section, the term “minimal amount” means
23 not more than 15 percent of the total amount made available for distribution under section
24 112(a)(1).

25 (b) Redistribution.—

26 (1) In general.—In any academic year that an eligible recipient does not expend all of the
27 amounts the eligible recipient is allocated for such year under section 131 or 132, such
28 eligible recipient shall return any unexpended amounts to the eligible agency to be
29 reallocated under section 131 or 132, as appropriate.

30 (2) Redistribution of amounts returned late in an academic year.—In any academic year
31 in which amounts are returned to the eligible agency under section 131 or 132 and the
32 eligible agency is unable to reallocate such amounts according to such sections in time
33 for such amounts to be expended in such academic year, the eligible agency shall retain
34 such amounts for distribution in combination with amounts provided under section
35 112(a)(1) for the following academic year.

36 (c) Construction.—Nothing in section 131 or 132 shall be construed—

37 (1) to prohibit a local educational agency or a consortium thereof that receives assistance
38 under section 131, from working with an eligible institution or consortium thereof that
39 receives assistance under section 132, to carry out career and technical education

1 programs or programs of study at the secondary level in accordance with this title;

2 (2) to prohibit an eligible institution or consortium thereof that receives assistance under
3 section 132, from working with a local educational agency or consortium thereof that
4 receives assistance under section 131, to carry out postsecondary and adult career and
5 technical education programs or programs of study in accordance with this title; or

6 (3) to require a charter school, that provides career and technical education programs or
7 programs of study and is considered a local educational agency under State law, to jointly
8 establish the charter school's eligibility for assistance under this title unless the charter
9 school is explicitly permitted to do so under the State's charter school statute.

10 (d) Consistent Application.—For purposes of this section, the eligible agency shall provide
11 funds to charter schools offering career and technical education programs or programs of
12 study in the same manner as the eligible agency provides those funds to other schools. Such
13 career and technical education programs or programs of study within a charter school shall be
14 of sufficient size, scope, and quality to be effective.

16 SEC. 134. [20 U.S.C. 2354] LOCAL APPLICATION PLAN
17 FOR CAREER AND TECHNICAL EDUCATION
18 PROGRAMS.

19 (a) Local Plan Application Required.—Any eligible recipient desiring financial assistance
20 under this part shall, in accordance with requirements established by the eligible agency (in
21 consultation with such other educational training entities as the eligible agency determines to
22 be appropriate) submit a local plan application to the eligible agency. Such local plan
