Advance CTE, in partnership with the Association for Career and Technical Education (ACTE), American Association of Community Colleges (AACCC) and the National Alliance for Partnerships in Equity (NAPE), is hosting a series of four regional meetings to help state leaders best leverage the newly reauthorized Strengthening Career and Technical Education for the 21st Century Act (Perkins V) to advance learner access to and success through high-quality Career Technical Education (CTE) programs and programs of study.

Objectives – Participants will:

- Gain a deep understanding of the benefits and challenges of Perkins V by learning from national experts about the law and the leadership levers within it;
- Engage with peers from within and across states to share promising practices and brainstorm strategies around data and accountability, programs of study, state-to-local implementation, and advancing equity in CTE; and
- Leave with a clear data-driven strategy, timeline and process for developing a new Perkins V state plan that advances their statewide vision for CTE.
