# **Reporting on Work-Based Learning in Arkansas**

Work-based learning has gained prominence in the most recent Perkins Act, and in fact more than half of states have designated work-based learning as one of their quality indicators. Even for states that don't include work-based learning as a quality indicator (like Arkansas), the need to track and report on work-based learning activity is a high priority for CTE leaders. In order to increase data quality and significantly reduce the reporting burden, the Arkansas Department of Education, Division of Career and Technical Education, recently launched a customized statewide work-based learning management system. Participants in this session will hear from CTE leaders at ADE about their decision to launch a statewide system, how the system was customized to meet ADE needs, and their experiences since launching in January 2021.

# Area Technical Centers- Under-utilized and Under-appreciated

There are nearly 1,4000 area technical centers (ATCs) in the United States but many policymakers and stakeholders are unaware of their existence. Bolstered by key findings from a Lumina Foundation-sponsored study, this session will illustrate how, as largely open-access institutions, ATCs can be leveraged to upskill and reskill learners, provide training to incumbent workers, and nimbly respond to





the needs of business and industry in a local community. Recommendations from the study will be presented alongside state examples to demonstrate the significant variance in how these institutions function nationwide, including in their governance, populations served and role in the community. ## Effective and Equitable Messages for CTE Program Recruitment: A Research Update

States play a key role in setting the messaging and narrative about CTE so that all stakeholders, particularly learners and families, understand the value and benefit of CTE programs. #### **Equity Workshop Part One**

This 90-minute workshop will dive into how to lead courageous conversations about race and CTE internally and with key stakeholders. State leaders have made commitments to advancing equity in CTE, most notably in their state Perkins V plans. However, there is often a disconnect between these commitments and the data, which show persistent opportunity and outcome gaps for historically marginalized learners. In order to understand this disconnect, state CTE leaders have to engage in honest and meaningful dialogue about the systemic and structural challenges facing marginalized learners in order to develop effective policies, programs and practices. This workshop introduces state CTE leadership to the latest Advance CTE tool designed to support facilitation of discussions on topics related to equity in CTE, with a focus on racial equity. Through interactive activities and small group discussions, participants will leave the workshop with awareness, knowledge and skills to begin engaging in meaningful discussions around equity in CTE policy and practice.
