My name is Angelo Chupungco and I am the Director of Public Safety Training Institute, LLC. In conjunction with Passaic County Community College, I have taught in Passaic County Technical Institute for several years. My class, NECI BASIC 911 OFFICER Course and NEW JERSEY EMERGENCY MEDICAL DISPATCH Course as part of PCTI Criminal Justice Program. Once the student finished the courses, he/she receives a National Certification from New Jersey State Office of Emergency Telecommunications Services and National Emergency Communication Institute that certifies the student as a police dispatcher. Along with the national certifications that is good anywhere in the continental United States, the students also received six (6) college credits from PCCC.

This is a wonderful program that benefits the students. It gives them the advantage over someone who has not taken the course. As in most cases, Police and Emergency Communication Centers prefers candidates that already have their certificates and/or registered in a current course in order to be considered for the job. Please be advised that Passaic County Community College (PCCC) has an articulation agreement whereby Passaic County Technical Institute (PCTI) students receive three college credits for several criminal justice classes, through concurrent enrollment, whereby certified PCTI instructors are qualified as experts in their instructional area. The courses include:

1. Introduction to Criminal Justice
2. Introduction to Homeland Security
3. Juvenile Delinquency and Youth Crime
4. Investigative Function/Criminal Investigation
5. Drug and Alcohol Use, Misuse, and Abuse

Students can earn a Certificate of Achievement in Criminal Justice Studies for completing Introduction to Criminal Justice or Introduction to Homeland Security AND 3 other criminal justice courses.

In addition, students enrolled in the following courses can earn a state-certified career certificate after successfully completing an EMT Training course and state exam. This is an 8 credit course.

Lastly, students can earn a career certificate in Public Safety Telecommunications after enrolling in the following courses:

1. Public Safety Communications
2. Emergency Medical Dispatch
3. First Aid and CPR Training
