State CTE Director Changes

- On July 1, there were many State Director transitions. Below are the transitions that have not yet been shared in this space.
 - Pradeep Kotamraju will leave his role in Iowa to move to sunny California to serve as the State Director. Pat Theiben will serve as the acting Bureau Chief in Iowa during the transition.
 - o Alaska is also welcoming a transition as Niki Tshibaka takes the reins.
 - Emily Passias of Ohio is leaving her post to join the Education Strategy Group as the Assistant Director of College and Career Readiness. Leah Amstutz will serve as the acting director during the transition.
- On July 3, Mississippi will have a new State Director. Aimee Brown is joining the Department of Education after serving as a local CTE leader for many years.

Priority: Develop internal PROCESSES and PROTOCOLS to ensure a strong and sustainable organization

Finance Update: As of June 30, fiscal year 2019 is complete. While year-end financials are still being closed out (payroll reconciliation for June, along with investments for May and June need to be finalized) initial reviews confirm that the year ended very strong. The annual audit has been scheduled for the first week of November, a bit later than in years past due to the Perkins implementation meetings.

2019 Perkins V Implementation Meetings

- In May, Advance CTE launched registration for the next round of implementation meetings, to be held in August, September and October 2019. These meetings will be different from the last round, as they will be designed to foster cross-state sharing and enable states to get targeted feedback on their plans and strategies, while providing ample time for state team time and access to national experts and facilitators.
- These meetings will be co-hosted by the same core partners ACTE, NAPE and AACC and national experts form partner organizations like National Skills Coalition, National Governors Association, JFF, NACEP, Institute for Educational Leadership, CLASP, New America, Data Quality Campaign and Education Strategy Group will also be participating.

<u>2020 Spring Meeting:</u> Staff are sourcing DC-area hotels for our 2020 Spring Meeting contract. We are looking to May or June for the meeting to align with states' submission of their Perkins V plans. During this meeting, Advance CTE will celebrate its 100-year anniversary.

Priority: Ensure the adoption and implementation of high-quality state and federal CTE POLICY.

Federal Advocacy Plan: In June, Advance CTE targeted its advocacy efforts around the Fiscal Year 2020 (FY2020) appropriations process and the reauthorization of the Higher Education Act (HEA). In addition, we continued to provide resources to our members on Perkins V implementation and the campaign to double the investment in CTE.

The Strengthening Career and Technical Education for the 21st Century Act (Perkins V)

 Advance CTE staff presented about Perkins V at the National Association of State Workforce Agencies meeting of the Labor Market Information Committee.

- Advance CTE has continued to support our members as they work to develop their four-year state plans and relay accurate information to our partners in the education and workforce communities.
- Perkins V State Transition Plans were due to the U.S. Department of Education Office of Career, Technical, and Adult Education last month. Advance CTE will review each plan as plans become available.
- We have also continued to post our Perkins V resource roundup e-blast and blog. The latest editions were "Perkins V: How Can States Promote Quality Postsecondary CTE?" and "Perkins V: How Can States Improve CTE Data and Its Use?"

Appropriations: In June, the House of Representatives moved ahead with the Labor, Health and Human Services, Education, and Related Agencies (Labor-HHS-Ed) appropriations process by packaging it with the funding bills for the Defense, State, Foreign Operations, and Energy and Water, into a minibus appropriations bill, H.R. 2740 Members of the House proposed a total of 189 amendments to the Labor-HHS-Ed portion of H.R. 2740, and the House Committee on Rules determined that <u>77 of these would be considered</u>. Representative Angie Craig (D-MN) proposed one of these amendments, an amendment that brings attention to the importance of CTE (however, it does not increase or decrease the money allocated to CTE State Grants). The following week the House passed H.R. 2740 on a 226-203 vote. The bill included close to \$1.3 billion for CTE State Grants leading to a total increase of \$47 million over the amount provided by Congress for FY19. However, the final House bill is unlikely to pass into law. The Senate Appropriations Committee has still not yet released their FY20 funding bill for Labor-HHS-Ed. In addition, Congress has not yet agreed on the overall levels of spending for defense and non-defense discretionary spending, which must happen before final allocations for the FY20 appropriations bills can be determined. Congressional leadership and administration officials met in June to attempt and come to an agreement, but talks are ongoing.

Campaign to Double the Investment in CTE

- Advance CTE continued the campaign to double the investment in CTE in June. Thus
 far, the campaign has the support of 264 employers, with the state of Virginia taking
 the lead with over 79 signatures. These employers are small businesses as well as
 major corporations representing every Career Cluster across 29 states.
- Advance CTE has continued to highlight the campaign's resources, including blogs, sample Tweets and materials for sharing the campaign (e.g., promotional toolkit, fact sheet, etc.) in a bi-monthly newsletter.

Workforce Innovation and Opportunity Act (WIOA)

 Advance CTE staff presented at a Workforce System Performance and Innovation Working Group meeting, hosted by the American Enterprise Institute, about opportunities and practices for alignment between WIOA and Perkins.

Higher Education Act (HEA)

• On June 26 the Jumpstart Our Businesses by Supporting Students (JOBS) Act, H.R. 3497, was introduced in the House by Representatives Cedric Richmond (D-LA), Andy Levin (D-MI), Anthony Gonzalez (R-OH), Jaime Herrera Beutler (R-WA), Steven Horsford (D-NV) and John Katko (R-NY). The JOBS Act was introduced in the Senate (S.839) this

past March by Senators Tim Kaine (D-VA) and Rob Portman (R-OH). This legislation would expand Pell Grant eligibility to high-quality short-term postsecondary programs that are at least 150 clock hours over at least eight weeks, meet local or regional labor market needs, articulate to institutional credit and provide students with a recognized postsecondary license, certification or credential.

- Advance CTE is continuing to monitor what the 116th Congress will mean for HEA reauthorization by meeting with partners in the higher education space, attending briefings, hearings, webinars and coalition meetings to gather information and adjust our strategy.
- Advance CTE is continuing to meet with Congressional offices to share our priorities and highlight alignment with the HEA priorities of members of Congress.

Every Student Succeeds Act (ESSA)

- U.S. Secretary of Education Betsy DeVos released final <u>non-regulatory guidance</u> on the supplement not supplant requirement under Title I of the Every Student Succeeds Act (ESSA) following a 30-day public comment period. The intention of the new guidance is to provide more flexibility in how local education agencies spend their Title I funds.
- Senator Cory Booker (D-NJ), Congressman Donald Norcross (D-NJ) and Congressman Bill Pascrell (D-NJ) <u>introduced</u> new legislation to support professional development and loan forgiveness for teachers. Among other things, the Supporting the Teaching Profession Through Revitalizing Investments in Valuable Educators (STRIVE) Act would increase and require Congress to fully fund Title II of ESSA, which supports professional development and training of effective instructors.
- In June, Advance CTE co-authored a <u>blog</u> with the Afterschool Alliance about career-focused afterschool programs for middle schools. The blog post is the first in a three-part blog on intersections between afterschool programs (which are often funded through Title IV-B of ESSA) and CTE.
- Advance CTE also worked with the Education Commission of the States (ECS) on a
 guest post for ECS's new blog series on work-based learning. The focus of the blog was
 on using Perkins V and ESSA to strengthen and expand work-based learning
 opportunities for youth.

Perkins Implementation Strategy: Advance CTE's Perkins implementation strategy is underway, with many core elements already in place.

Technical Assistance:

- Indiana, New York and Washington have continued to receive coaching from former State Directors; based on interest from the Gates Foundation, we have also extended coaching to California.
- In April, Advance CTE put out an RFP for a group of 12 priority states, as identified by Gates and Joyce. The RFP asked states to identify top challenges they want support in as they advance their Perkins V state plans. Based on the review of these plans and follow up with states, we will be providing technical assistance between June 2019-April 2020 to six states: Illinois, Minnesota, Ohio, Oregon, Tennessee and Texas. The supports will range from supporting stakeholder engagement and state-level coordination to digging into strategies for closing equity gaps and aligning programs of study.

Shared Solutions Workgroups (SSW)

- Advance CTE's first of Shared Solutions Workgroups, focused on the comprehensive needs assessment (CLNA), held two virtual meetings in June 2019 and released the first set of deliverables:
 - Driving Quality & Equity in CTE: A State Guide to Developing the Perkins V Comprehensive Local Needs Assessment Template; and
 - State Needs Assessment Crosswalk
- This Workgroup will wrap up by August 2019 and there are two additional deliverables planned: a guide to support regional collaboration through CLNAs and local applications and a brief piece on how states can and should commit resources to support CLNA implementation at the local level.
- The next SSWG will focus on middle school CTE and be launched in fall 2019.

Other Supports

- Advance CTE continues to support virtual cross-state sharing through the Moodle and Fourth Friday calls. After the June Fourth Friday call, these will be paused until after the Perkins implementation meetings are completed.
- Advance CTE has begun planning for the "Expert Peer Review" it will be offering to states in fall 2019 to have national experts provide actionable feedback on draft state plans.

<u>State Policy Update</u>

The Partnership to Advance Youth Apprenticeship (PAYA): This month, Advance CTE joined all of the PAYA project partners to announce the nine sites that were selected as grantees. Another 40+ sites were selected to be part of the broader PAYA Network. Advance CTE is in the process of updating the memorandum of understanding with project partners, which will be completed by August 2019 and will clarify Advance CTE's role in the initiative moving forward.

Equity Initiative: Advance CTE released its fourth equity brief in the <u>Making Good on the Promise series</u> in June. The fourth equity brief, <u>Making Good on the Promise: Expanding Access to Opportunity</u>, examines strategies state leaders can use to expand CTE opportunities for each learner. It highlights examples from Ohio, Rhode Island, South Carolina and Tennessee.

CTE Data Initiative: After the release of the State of CTE report in April, Advance CTE has had two priorities for the data initiative: disseminating the findings from the report and exploring opportunities to expand and sustain the initiative. In June Advance CTE staff presented at a meeting of the CTE Research Network and led a discussion with researchers about the importance and limitations of data quality in conducting research in CTE. Also in the works is a short series of briefs on each of the secondary CTE program quality indicators that draws on the state survey to share promising practices and approaches for each option. The briefs are scheduled to be published in July. Advance CTE has also been in talks with ECMC Foundation about opportunities to expand the data initiative and provide additional supports and technical assistance to states.

Policy Year in Review Partnership: In June, Advance CTE kicked off a new partnership for the annual <u>State Policies Impacting CTE: Year in Review</u> report. In addition to ACTE, which has co-authored the report with Advance CTE since 2013, the Education Commission of the States will now be a lead partner and author. This partnership will add new muscle to Advance CTE's ability to track real-time changes in state policy, though the substance and format of the report will remain the same.


Oregon Perkins V Planning: Advance CTE has a contract with Oregon to facilitate and guide the state's development of its four-year Perkins V state plan. Advance CTE is currently developing an action plan for Oregon that will map out the steps the state must take to put together a comprehensive plan. Additionally, Advance CTE, in partnership with the Association of Career and Technical Education, will facilitate work groups in July to gather detailed feedback to inform the state's final Perkins V plan.

Postsecondary Strategy: Advance CTE staff are progressing through the activities proposed in the organization's postsecondary strategy. In partnership with Higher Learning Advocates, Advance CTE published a new 101: Career Technical Education fact sheet, with a focus on postsecondary CTE. Advance CTE also continues to participate in the Community College Working Group led by Opportunity America. After the release of the report <u>Developing Credit for Prior Learning Policies to Support Postsecondary Attainment for Every Learner</u> in April, staff have continued to disseminate the findings and promote the release as well.

State Web Profile Redesign: In June, Advance CTE began updating the <u>state web profiles</u> on careerech.org, which include comprehensive information about the scope, reach and performance of CTE in each state. In addition to updating the data and information on each state's page, Advance CTE is working with the careertech.org web developed to redesign and improve the functionality of the pages so they are more useful for state leaders, journalists and CTE advocates. The project will conclude by the end of summer 2019.

Learning that Works Resource Center: The Resource Center sustained a total of 9,282 hits for the month of June (as reported on June 25). The top two resources for this month include

American Institute for Research's 50-state scan of CTE teacher licensure policies, followed by Advance CTE's Making Good on the Promise: Expanding Access to Opportunity report. The most visited topic page was Work-based Learning, followed by Credentials and Assessments. The least viewed topic pages were Instructor and Leader Quality and Cross-Sector Strategies and Governance (formerly Systems Alignment). Advance CTE is in the process of updating the Resource Center landing page, which should be completed in July.



JUNE 2019 COMMUNICATIONS REPORT



Strategies for Attracting Students to High-Quality CTE (Siemens Grant): Staff has continued working with cohort three, which includes four states (AR, GA, IA, and UT). Staff traveled to Georgia to develop their communications plan in May alongside staff. Advance CTE staff developed the communications plan and presented it to Georgia staff members in June.

Staff has also continued the contract with Fenton, a communications firm to help make the assets created under this grant more visible and easily accessible; the goal is for the work to be completed by fall 2019.

Staff has delivered the Career Advising and Development Training, one of which took place in Massachusetts in June. The training will be delivered in 15 states between now and December 2019 through ASCA and ACTE statewide chapters, as well as state CTE offices. Components of the training will be delivered virtually through ASCA's online platform beginning in summer 2019.



In June, Advance CTE focused our advocacy efforts on the reauthorization of the Higher Education Act (HEA) and the Fiscal Year 2020 appropriations process. With the U.S. Department of Education releasing new <u>draft regulations</u> related to postsecondary education, an expanded <u>College Scorecard</u>, and a new Experimental Sites Initiative to pilot new policy changes, Advance CTE has been working with Congress and the Administration to share our <u>HEA priorities</u>.

In addition, Advance CTE has continued to release our Perkins V Resource Roundup. Check out the new editions: Perkins V: How Can States Improve CTE Data and its Use? and Perkins V: How can states promote quality postsecondary CTE?



State Policy Overview

On June 14, in **Texas** Governor Greg Abbott signed <u>HB963</u> into law. Under the law, the State Board of Education is required to conduct a review of the essential knowledge and skills of CTE applications and curricula.

In **Maine**, on June 10, Governor Janet Mills signed <u>LD1240</u> into law. Under the law, a graduate of a secondary CTE electrical program is qualified to sit for an examination approved by the board and is credited 1,000 hours of work experience in electrical installations.
