Organizational Update: Due to Scott's departure, staff have reorganized some work internally and have posted a [new position, Senior Advisor for Equity](#). We'll be re-opening our search for a State Policy Manager, as our last search did not result in a successful hire.

Finance Update: These numbers represent the FY21 year-end finances through June 30, 2021, which is 100% of the fiscal year. We are still closing out some final bills and invoices, so our records are not yet closed out for the fiscal year. Our final FY21 actuals will be shared at the September Board Meeting. Both organizations are closing out FY21 in a very strong financial position.

Member Engagement & Professional Learning: Advance CTE held the first two of five Lunch & Learn sessions on the Without Limits vision principles. Each session featured three partners discussing their support of the vision and ways they may support states in implementing the vision. Attendees then moved into breakout rooms to discuss the principles further and to build connections between the vision and their work. Advance CTE is measuring the impact of these Lunch & Learns by asking attendees at the start and end of each session to evaluate how much they know about the principle and how ready they feel to advance the principle in their work. This is displayed in the table below.

Advance CTE held regional calls for State CTE Directors in June and 21 State Directors attended across the five calls. There were six sets of regional calls held between August 2020 and June 2021 and 49 State Directors joined at least one of the six calls for their region. No states attended all six calls but seven states attended five.

Priority: Ensure the adoption and implementation of high-quality state and federal CTE POLICY.

Federal Advocacy Update: At the end of last month, the White House released its Fiscal Year 2022 (FY22) full budget proposal. As a reminder, differently from prior years this proposal did not only list requests for the FY22 appropriations bills, but also named requested funding through the American Jobs Plan and American Families Plan. This request calls for a \$20 million increase (only approximately 1.5%) to the Perkins Basic State Grant, as well as a \$108 million increase for National Programs- of which \$100 million would fund competitive awards for middle and high school CTE innovation projects aimed at advancing equity and \$8 million would fund technical assistance and grant evaluations. Advance CTE was disappointed by the 1.5% increase for the Basic State Grant. Interestingly, the request also includes a new \$1 billion annually for 10 years to support middle and high school career pathways- this funding would happen separately through the passing of the American Jobs Plan (AJP). When the different funding streams come together, the Administration requested essentially doubling the investment in CTE- an encouraging signal of support for the CTE community. Advance CTE in partnership with the Association for Career and Technical Education (ACTE) released a statement on this proposal, which can be viewed [here](#).

This month, Advance CTE, in partnership with ACTE, sent a letter to appropriators analyzing the impact of the budget proposal, and requesting that the full AJP funding be included in the FY22 appropriations bill through the Basic State Grant. This request was also submitted in a written testimony to the Senate. Both documents explained that the CTE community would welcome funding in any form, but discussed the impact of the Basic State Grant and why it is an equitable and efficient avenue to deliver funding and why an increase in federal funding for CTE is imperative.

Also, this month, the Preparing and Retaining Education Professionals (PREP) Act was endorsed by Advance CTE and reintroduced by Senators Tim Kaine (D-VA) and Susan Collins (R-ME), members of the Senate Health, Education, Labor and Pensions (HELP) Committee to address teacher and principal

shortages. The PREP Act particularly addresses shortages in rural areas, and ways to increase teacher diversity. Senator Kaine is also one of the Co-Chairs of the Congressional CTE Caucus. The legislation would expand the definition of high need districts under the Every Student Succeeds Act (ESSA) to include schools with teacher shortages in rural communities as well as in “core academic subjects,” which includes CTE.

Advance CTE also replied to a Federal Register “Notice of Intent to Reestablish the Advisory Committee on Apprenticeship (ACA) Charter and Request for Member Nominations” with nomination requests for three State CTE Directors.

State Policy Update:

Advancing The Framework: In June, Advance CTE and Vivayic hosted the second of two facilitated workshops that brought together 15 national experts to discuss the ideas and future steps of the Advancing the Framework initiative. We are finalizing the development of a prototype to bring to the Board of Directors in August.

Data Initiative: Advance CTE is providing direct technical assistance to the five funded states in the Advancing Postsecondary CTE Data Quality Initiative (PDI). This month, Advance CTE completed research on competency-based postsecondary pathways and work-based learning policy manuals. Additionally, Advance CTE hosted another problem of practice discussion with the full community of practice.

The Data Quality workgroup is continuing its work on the metrics framework and CTE equity index. The metrics framework, which lists a continuum of career readiness metrics at the middle school, high school and postsecondary level, is in the final stages of development and will be released in August. The CTE equity index is still in development. The objective of the index is to provide an index and analytical framework for evaluating the degree to which CTE programs are equitably serving and supporting all learners.

Learner Voice Shared Solutions Workgroup: The CTE Learner Voice SSWG met for the final time on June 23rd to gather the last remaining input for the learner voice toolkit that will be released in August.

Opportunity Gap Workshop: Advance CTE has reworked the rollout plan for the opportunity gap analysis workshop, aiming to host a train-the-trainer program in the fall. Participants will get hands-on training on identifying and addressing equity gaps in their data. Materials for the workshop - including a dashboard template, facilitation guide, and PPT slides - were completed this month and are going through the design process.

College in High School Alliance: For the last year, Advance CTE has served on the Steering Committee for the CHSA. In the past month, CHSA selected six states (Connecticut, Illinois, Kentucky, Minnesota, Ohio and Oklahoma) to receive intensive technical assistance to strengthen their overall systems around dual/concurrent enrollment, with a particular focus on addressing equity gaps. Advance CTE will be providing technical assistance to two of these states (Kentucky and Oklahoma), both of whom identified expanding CTE dual enrollment as a component of their strategies.



This month, Advance CTE has advocated for increased funding for CTE through the FY22 Labor, Health and Human Services, Education and Related Agencies appropriations bill, including sending a letter to Congress and submitted written testimony.

Advance CTE also endorsed the Preparing and Retaining Education Professionals (PREP) Act. This bill was reintroduced by Senators Tim Kaine (D-VA) and Susan Collins (R-ME), members of the Senate Health, Education, Labor and Pensions (HELP) Committee to address teacher and principal shortages. The PREP Act particularly addresses shortages in rural areas, and ways to increase teacher diversity. Senator Kaine is also one of the Co-Chairs of the Congressional CTE Caucus. The legislation would expand the definition of high need districts under the Every Student Succeeds Act (ESSA) to include schools with teacher shortages in rural communities as well as in “core academic subjects,” which includes CTE.
