**Fundraising:** Advance CTE is currently pursuing a variety of federal, corporate and foundation contacts to discuss potential grants and contracts. Below is a chart explaining this month's engagement with various development opportunities.

# Priority: Empower members through PROFESSIONAL LEARNING

**Membership Update:** In September, Advance CTE received three new memberships – three state members; 0 associate state members; 0 associate non-state members, 0 organizational members.

Priority: Ensure the adoption and implementation of high-quality state and federal CTE POLICY.

**Federal Advocacy Plan**: In September, Advance CTE held the second Perkins V Implementation Meeting and continued to support states as they develop their four-year plans. Advance CTE also continued advocacy efforts around the Fiscal Year 2020 (FY20) appropriations process and the reauthorization of the Higher Education Act.

## **Appropriations**

- In September, the Senate Appropriations Committee voted on the funding caps for each of the 12 Fiscal Year 2020 (FY20) appropriations bills. This included just a one percent increase for the Labor, Health and Human Services, Education, and Related Agencies bill (Labor-HHS-Education). Advance CTE joined the Committee for Education in sending a letter to the full Senate opposing this insufficient funding level. Later in the month, the Senate Appropriations Committee released the <u>text</u> of the Labor-HHS-Education bill. As written, this would keep Perkins state grant funding flat at FY19 levels. A committee mark-up of this bill has not yet been scheduled after it was cancelled in September.
- On September 19, the House passed a stopgap funding bill that would continue federal funding through November 21- allowing additional time for appropriators to finalize the longterm FY20 bill. The Senate voted to pass this stop-gap funding bill on September 26. President Trump signed this bill into law on September 27.

### Campaign to Double the Investment in CTE

Advance CTE continued the campaign to double the investment in CTE in August. Thus far, the
campaign has the support of 426 employers, the state of Virginia taking the lead with over 103
signatures. These employers are small businesses as well as major corporations representing
every Career Cluster across 35 states.

# **Higher Education Act (HEA)**

- In September, Representatives Lori Trahan (D-MA), Chris Pappas (D-NH), Kendra Horn (D-OK) and Abby Finkenaur (D-IA) introduced <u>The Strengthen CTE in Higher Education Act</u> (H.R. 4371). This bill would authorize nearly \$200 million in funding to strengthen program alignment for postsecondary Perkins Career Technical Education (CTE) programs through collaboration between postsecondary CTE and partners in education and the workforce. Advance CTE supports this bill, and provided a quote for the <u>press release</u>.
- On September 26, Senate House Education Labor and Pensions (HELP) chair Lamar Alexander (R-TN) introduced a package of eight bipartisan bills entitled the <u>Student Aid Improvement Act of 2019</u> (S. 2557). This package includes many of Alexander's long held priorities, like simplifying and streamlining FAFSA submissions. It includes some proposals that are included in our <u>HEA recommendations</u>, like reinstating Pell grant eligibility for prisoners. The bill also includes an expansion of Pell grants to cover short-term non degree programs, in many ways similar to the <u>JOBS Act</u>. Though the JOBS act is limited to public institutions only, Alexander's bill would include private and for-profit institutions as well. We support expanding short-term Pell eligibility for quality programs, but we are concerned that Alexander's bill opens the door to the possibility of lower quality programs that don't feature sufficient accountability or oversight.
- HELP ranking member Sen. Murray (D-WA) has expressed concern with Alexander's approach
  to taking a piecemeal approach to HEA reauthorization and has advocated for a
  comprehensive solution.
- A confidential draft of the forthcoming House Higher Education Act reauthorization bill has been distributed to selected national higher education organizations. The draft bill, over one thousand pages in length, has been received with much support. Timing of the bill's introduction is still uncertain.

**Perkins Implementation Strategy:** Advance CTE's Perkins implementation strategy is underway, with many core elements already in place.

#### **Technical Assistance**

- In addition to New York and Washington, California will also be receiving this form of coaching support. This intensive coaching is designed to provide the state with generalized support for their Perkins planning and implementation processes.
- We have been providing topic-specific technical assistance between June 2019 and April 2020 to seven states: Florida, Illinois, Minnesota, Ohio, Oregon, Tennessee and Texas. The supports range

from supporting stakeholder engagement and state-level coordination to digging into strategies for closing equity gaps, aligning programs of study, revamping state monitoring systems, communications plans, etc. As appropriate, Advance CTE will take the assets created for specific states and turn them into resources for all states.

## **Shared Solutions Workgroups (SSW)**

- Advance CTE's second Shared Solutions Workgroups, focused on middle grades CTE, launched in September. The charge is to identify and develop resources that support the design and implementation of policies, programs and practices that support and expand meaningful CTE/career-focused experiences in grades 5-8.
- The states involved include: Nebraska, Ohio, Tennessee, North Carolina, Delaware, Idaho, Maine, Virginia, Iowa, South Dakota and Utah. National partners include: American School Counselors Association, ACTE, Southern Regional Education Board, National Forum to Accelerate Middle-Grades Reform, Center for American Progress and Education Northwest. We also have two practitioners participating.
- The first virtual meeting was held in September; the next meeting and an in-person meeting will be in October. We anticipate the first deliverables out in November or December 2019.

### **Other Supports**

 Advance CTE's "Expert Peer Review" officially launched on September 30 (and will run through mid-January 2020). In total, 40 states signed up to participate and we confirmed 22 expert peer reviewers (all of whom went participated in pre-review training), including seven former State Directors, two former OCTAE staff (including a former Assistant Secretary of OCTAE), three CEOs/Presidents of national non-profits, and representatives from K-12, postsecondary and workforce development.

## **State Policy Update**

**CTE Data Initiative:** Advance CTE is finalizing a comprehensive data quality strategy, which will include a number of activities such as launching a Shared Solutions Workgroup on reporting/ data visualization, writing a blog series on CTE research opportunities, and developing technical assistance around equity gap analysis.

**Equity Initiative:** The final brief in the <u>Making Good on the Promise</u> series, titled <u>Making Good on the Promise</u>: Ensuring Equitable Success through CTE, is scheduled to be released in late October. The report is in the final stages of review. Advance CTE expects to receive feedback from featured states, national New Skills for Youth project team partners, and volunteers from the equity committee. Advance CTE is also in the early stages of developing technical assistance to help states conduct an equity gap analysis. This work is part of the Perkins V implementation strategy, funded through the Bill & Melinda Gates Foundation and the Joyce Foundation, and will ideally culminate in a suite of templates, guides and protocols for conducting a comprehensive equity gap and root cause analysis at the state or local level. In addition, Advance CTE is in the process of developing an equity guide that draws on the strategies from the <u>Making Good on the Promise</u> series to help state leaders advance equity in CTE. Advance CTE is in the process of writing the first draft of the guide.

**Iowa Perkins V Facilitation & Consultation Proposal:** Advance CTE and the Association for Career and Technical Education (ACTE) were selected as the winning proposal by the Iowa Department of Education's Bureau of Career and Technical Education to provide facilitation and consultation services in support of Perkins V implementation. The work will include facilitation of Iowa's State Advisory Council and subgroup meetings, consultation with agency staff members, and

management of the State Plan public comment process. The contract is expected to be awarded in early October and the work will take place through March 2020.


**New Skills for Youth (NSFY) Snapshots and Summary:** Advance CTE is in the process of developing the final round of the New Skills for Youth (NSFY) initiative snapshots and summary. Unlike past snapshots, these snapshots will examine states' impact across the entire NSFY initiative, beginning in 2016 with Phase One. Advance CTE is in the process of editing the snapshots and writing the summary.

**Oregon Perkins V Facilitation:** To make the best use of the opportunities for innovation afforded by Perkins V, CTE leaders from the Oregon Department of Education (ODE) and the Office of Community Colleges and Workforce Development (CCWD) have contracted with Advance CTE to facilitate stakeholder engagement, planning for the new legislation and broader CTE systems improvement. In September, Advance CTE, in partnership with the Association for Career and Technical Education (ACTE), provided feedback on documents related to Oregon's Perkins V plan to help inform the development of the state's plan. Advance CTE, in partnership with ACTE, is currently planning in-person workgroups, which will take place in October, to help inform Oregon's state Perkins V plan.

**The Partnership to Advance Youth Apprenticeship (PAYA)**: Advance CTE staff attended the PAYA National Grantee Meeting in Denver, Colorado. All nine of the PAYA grantees were represented at the meeting, as well as national PAYA partners. The convening focused on the grantees' Action Plans and next steps. Advance CTE presented on "Data for Accountable Youth Apprenticeship Programs and Partnerships." Staff also continue work on a new youth apprenticeship resource.

**Postsecondary Program Approval – Joyce Foundation:** Advance CTE staff attended the Illinois Community College Board's (ICCB) "Processes that Foster High-Quality Programming" training. This was the culmination of the program approval review process and new Program Approval Manual that ICCB undertook. Advance CTE staff presented on the CTE Program Approval Policy Benchmark Tool. Advance CTE also spent a day at Waubonsee Community college with administrators, faculty and students.





### View from the Hill

In September, Advance CTE continued to advocate our priorities for the Fiscal Year 2020 (FY20) appropriations process and reauthorization of the Higher Education Act (HEA). The Senate Appropriations Committee returned from August recess and voted on the funding caps for each of the 12 FY20 appropriations bills. This included just a one percent increase for the Labor, Health and Human Services, Education, and Related Agencies bill (Labor-HHS-

Education). Advance CTE joined the Committee for Education in sending a letter to the full Senate opposing this insufficient funding level. Later in the month, the Senate Appropriations Committee released the <u>text</u> of the Labor-HHS-Education bill. As written, this would keep Perkins state grant funding flat at FY19 levels. A committee mark-up of this bill has not yet been scheduled. Federal funding runs out on September 30, and appropriators in the House and Senate are working to come to an agreement before that time. On September 19, the House passed a stop-gap funding bill that would continue federal funding through November 21, allowing additional time for appropriators to finalize the long-term FY20 bill. A Senate vote for this measure has not been scheduled.

Advance CTE also supported the introduction of the Strengthen CTE in Higher Education Act. The full bill can be viewed <a href="here">here</a>, and a press release with a quote from Advance CTE can be viewed <a href="here">here</a>.



# **State Policy Overview**

In late August, **Illinois** Governor Jay Robert Pritzker signed <u>SB1525</u> into law. The law requires the Department of Children and Family Services to provide eligible youth an apprenticeship stipend to cover the costs associated with an apprenticeship, such as fees and occupation-specific tools. The law requires the Department to develop outreach programs to ensure qualifying youth are aware of the stipends.
